Product Information

1. Product description

General information: clear viscous yellow liquid with characteristic fragrance in uncoloured translucent plastic container labelled for retail sale.

Composition: multicomponent mixture composed mainly of water and detergents, with fragrance.

Physico-chemical characteristics: viscous liquid

Stability and reactivity: product is stable

2. Hazard information*

Undiluted product may irritate eyes and skin.

3. Handling advice

Precautions during use: No special precautions are required Exposure controls/Personal protection: None required

4. Storage considerations

Store in a dry place at <25°C

5. First Aid measures

Eyes: wash immediately with copious amounts of water and obtain medical attention if symptoms develop.

Skin: rinse skin with soap and water. Obtain medical attention if symptoms develop. Inhalation: Not anticipated. If inhalation does occur obtain medical attention immediately.

Ingestion: Drink 1 or 2 glasses of water or milk. Keep at rest. Do not try to induce vomiting. Obtain medical attention. Show this document.

6. Accidental release measures

Physically contain the spill. Mop up or use absorbent and sweep up. Dispose as appropriate. Spills must not be flushed direct to sewer except with the express permission of local regulatory authorities. If large amounts of material enter the surface drains, inform the local authorities.

7. Risk of explosion and ignition*

Not applicable – product is not flammable.

8. Disposal information

Bulk spills and waste product should be placed in secure containers and labelled clearly. Local regulatory authorities should be consulted about the most appropriate form of waste disposal.

9. Information relating to transport

No special precautions are required.

* Finished cosmetic products are exempt from the requirement for hazard symbol labelling.

NOTES CONCERNING THE LEGAL REQUIREMENT FOR SAFETY INFORMATION

The manufacture of cosmetic products is covered, in Europe, by the EU Cosmetics Directive (76/768/EEC), which will be replaced by the EC Cosmetics Regulation (1223/2009) in July 2013.

Finished cosmetic products are exempt from the legislation requiring the provision of 16-point Safety Data Sheets (SDS), sometimes referred to as Material Safety Data Sheets (MSDS).

The safety of chemicals is now controlled by the European REACh Regulation (Registration, Evaluation & Authorisation of Chemicals), but the exemption for cosmetics with regard to the SDS remains. Title IV covers information on the supply chain, and Article 2.6(b) of REACh exempts cosmetics from these requirements - including the need to supply safety data sheets for finished products. This applies to both consumer home-use and professional-use cosmetics.

An Information Sheet on REACh and SDS issued by the UK Health and Safety Executive (HSE) [http://www.hse.gov.uk/reach/resources/reachsds.pdf], includes a section on when and if an SDS is required. The leaflet clearly states that SDSs are not required for cosmetic products.

Notwithstanding the above, it is recognised that persons who store and transport cosmetic products in large quantities do require information on how to manage these products and the information contained in this document is intended for those purposes.
